

# General Terms and Conditions of Business

As of August 2024

The following terms and conditions apply to all participants, speakers and exhibitors/sponsors who register for the Leipzig Interventional Course ("LINC") via the public registration.

### 1. Contracting Parties

By registering for the LINC Course, the participant, speaker, or exhibitor/sponsor establishes a contractual relationship with Provascular GmbH (Cospudener Str. 1, 04416 Markkleeberg, Germany) and accepts LINC's participation conditions, the congress fees and LINC's exclusion of liability. Provascular GmbH is represented by CEO Joshua D. Hartman.

# 2. Congress Registration

Binding registration is made on the event website at www.leipzig-interventional-course.com. It is not possible to register by telephone. Congress registration will begin on 01 September 2024.

After purchasing the registration(s) you will receive a confirmation e-mail with your invoice. You must assign the registration(s) to the participant(s) who will attend the LINC on-site within one week of purchasing the registration(s). The registration(s) needs to be accepted and valid by the participant after assignment (Check in). On-site registration will be available.

# 3. Participation Fees<sup>1</sup>

The participation fees can be found on the event website, www.leipzig-interventional-course.com.

Participation fees include on-site participation, exhibition, and on-demand content, available for up to 6 months after the event (not included in day passes) <sup>1</sup>.

All fees include the local applicable VAT.

The amount due is based on the amount due on the date (CET) Provascular receives the payment and not the date of registration.

Payments are due at the time of registration. Registrations not paid will be cancelled after 1 week of registration and a new registration will be required at the then current rate. <sup>1</sup>

The registration fee may be paid by credit card (Visa, Mastercard, American Express, Discover, Diners Club, and China UnionPay), Apple Pay, Google Pay, PayPal, Link, Bancontact, EPS, giropay or iDeal.

### Bank transfer payments are not possible!

On-site you may pay by credit card (Visa Card, Master Card), Debit Card or Cash payment only. **Amex will not be accepted onsite.** Participants are responsible for any transfer and/or card fees.

The **reduced student registration** fee is only available to participants who have not concluded medical school and who are currently enrolled at a university. Please provide proof of your current university enrolment. We only accept ENGLISH or GERMAN verifications.

The **reduced nurse/AHP registration** fee is only available to participants who are currently employed as nurses or allied health professional (advanced practitioners like nurse practitioners, radiographers, and cath lab technicians (not physicians).

The **reduced fellow registration** fee is only available to participants who are currently employed as fellow and have finished medical school no longer than 6 years ago but are still in training of their first specialization.

**Industry registrations** are for participants, who work at a company that **does not** participate in sponsorship/support of LINC. Please note, if you are employed by industry and not a physician or working at a medical institution, you MUST register as "Industry."

Participants who work at a sponsoring/supporting company must register via the company sponsor registration account only to benefit from the company sponsor registration terms. Registrations made through the event website will not receive the company sponsor registration rates and will not be discounted or refunded. 1

# Cancellation/Rebooking/Handling Charges<sup>1</sup>

Written cancellation of the registration must be sent to Provascular by letter or e-mail to <a href="mailto:registration@leipzig-interventional-course.com">registration@leipzig-interventional-course.com</a>

Cancelation deadlines: 1

Until 31 October 2024, a refund of 100% of the registration fee will be made, minus a cancelation fee of 100 Euros.

From 1 November until 6 December 2024, a refund of 50% of the registration fee will be made.

After 6 December 2024, no refunds will be made. Fees already paid will not be refunded.

### Any change requested (re-bookings, invoice changes, name/e-mail address change) will result in an 80 Euro handling fee!

Changes requested after the original invoice has been issued will result in an 80 Euro handling fee. <sup>1</sup>

A registration is transferable to another person at any time for a handling fee of 80 Euros. If a reduced participation fee was booked by the original participant, proof of such must be provided so that it may be applied to the new participant. The new participant (replacement) must pay the congress and handling fees if they have not been paid already within 7 days. Fees already paid will not be refunded to the original participant. <sup>1</sup>

A refund will not be made in the case of no-show, illness, early departure, etc. A processing fee of 80 Euros will be charged for any changes to a registration, e.g., the participant's name, typing errors within the registration, e-mail address or payment address.

# **Congress Documents**

As soon as the participant has been assigned to the ticket, the participant needs to check in and fill in all relevant data and confirm the consent. After that the ticket QR-Code becomes valid. Assigned tickets need to be activated (checked in) to be valid for the badge print on-site.

Please bring the QR code to Leipzig (digital or analogue)!

Participants may be required to show ID/Passport for verification purposes to pick up the badge. Participants will not be allowed to access the congress without a badge. All participants must wear their badge at all times during the congress. Badges are not transferrable.

Please keep your badge safe, as replacements won't be made without exception. We charge a badge re-print fee in case of loss/forgotten of 200 Euros per re-print.

After the congress has finished, participants will be able to watch LINC's on-demand content via their participation account. The on-demand videos will be available approximately 2 weeks after the congress for 6 months.

#### Programme

Provascular expressively reserves the right to change the congress topics listed in the programme or to engage other lecturers. Provascular also reserves the right to make changes regarding the announced Global Expert Exchange, without assuming any liability for any such changes.

The organiser reserves the right to make changes to the programme.

Usage of the content from the LINC Congress is for personal educational purposes only. No content may be reproduced or used in any other manner without express written consent from both Provascular and the content presenter.

### Speakers' Responsibility

Speakers are responsible for ensuring the content they submit for presentations and other documents related to the course are correct and do not violate the rights of third parties. Provascular is not obliged to check the documents before publication for completeness or legal infringements, especially with regard to infringements of trademark rights of third parties.

Please note that the speakers alone are responsible for the content.

### Liability

The liability of Provascular GmbH, with the exception of liability for injury to life, body, or health of the participant, is limited to intent and gross negligence. This does not affect the liability of Provascular in case of violation of essential contractual obligations (cardinal obligations). In this case, the liability is limited to the amount of a damage typical for the contract and foreseeable at the time of the conclusion of the contract. As far as the liability of Provascular is excluded or limited, this shall also apply to the liability of representatives and vicarious agents. Provascular is not liable for damages or disturbances caused by circumstances beyond its control. This applies in particular if the event is impeded or prevented by unforeseen political, economic, climatic events or generally by force majeure.

The assertion of claims for damages is excluded if the realization of the congress or parts of it are made unreasonably difficult or impossible by unforeseen events which are beyond the organiser's control, e.g. political or economic events or force majeure. Participation in additional bookings and related events is at your own risk.

Provascular will be liable only for services actually performed by Provascular in accordance with the statutory regulations.

Any further liability is excluded. This shall apply in particular to third-party services provided by venue and/or catering services, transfer, and tourist services as well as other work performances or services. Provascular will only act as an intermediary here. Liability claims for such third-party services may only be asserted against the respective service provider. In addition, Provascular will be liable for faulty contractual performance, unlawful acts or, in the case of culpa in eligendo, for intent and gross negligence only.

During the congress, photographs, film, and video recordings of the event and of the participants will be produced. In observance of the Art Copyright Act (right to one's own image), the organizer may use the recordings free of charge in media releases and for congress-related promotion.

#### **Final Provisions**

Subsidiary agreements made orally are not binding unless they are confirmed in writing. Should parts of these terms and conditions be invalid, the validity of the contract remains for all remaining terms and/or conditions.
